

Bunscoill Rhumsaa COVID Response Plan



This document outlines the key actions that we will take at Bunscoill Rhumsaa, when there is an outbreak of Covid in the Community. It is important to understand that this is only a guide and that all action taken will be influenced by advice from DESC, Public Health and COMIN. In addition as the level of uptake of the Vaccine, and as more is known about COVID 19, our responses will change. The decision to move from one level to another will be taken by the Headteacher, or in their absence the member of staff in charge at that time. This decision will be made based on the most up to date information available at that time.

^{1 -} Home Learning. Some Home Learning activities will be made available for pupils in the event of significant staff absence or other reason resulting in groups or classes being asked to stay home. This will be in line with our school policy, and will include use of Education City, Bug Club, MyMaths etc. Until Level 3 is reached it will likely not be possible to provide daily Teams meetings, as the staff will be working directly with the rest of the children in school. This provision will not be routinely provided for children who are off school due to illness, as this is normally of a short duration, or children who are in isolation due to the family choosing to travel.

2 - Face coverings - The school will support any child or adult who wishes to wear a face covering at any time, for any reason.

^{3 -} Off site visits - This can cover a wide range of activities, some of which may well be safe to take place at level 1 e.g. a walk around the local area as part of a topic on 'Our Community', whereas a whole school trip to a concert at the Villa Marina would not be suitable. For this reason a decision on off site visits at this level will be made following a detailed risk assessment and consolation with other stakeholders.
